Highways Act 1980 - Section 116

BEFORE the Magistrates' Court sitting at 51 Holloway Road, London, N7 8JA

APPLICATION having been made by the London Borough of Camden (the Applicant) under section 116 of the Highways Act 1980 that an area of the highway being forecourt of the former properties at 14, 16 and 18 Castlehaven Road, London, NW1 situated within the London Borough of Camden with the following description:

The forecourt of the former properties at 14 16 and 18 Castlehaven Road as per the table below:

The highway / forecourt shown hatched red on plan 109791-00-046/P06 (the Existing Highway) should be stopped on the ground that it is unnecessary.

This order will not change the rights of any statutory utilities to access and maintain their plant or equipment within the areas highlighted in blue on drawing 209791-00-046/P06

AND the Court being satisfied that the Applicant has given the notices required by Part 1 of Schedule 12 to the Highways Act 1980 and that the written consent of every person having a legal interest in the land over which the highway is to be diverted has been obtained **AND** the Court having heard the Application.

AND the Court being satisfied that the said area of highway is unnecessary.

IT IS HEREBY ORDERED that the said area of highway be authorised to be stopped up for the purposes of all traffic.
