Camden fees and charges 2024/25



This document sets out Parking Operations current charges for the financial year 2024/25 and includes fees and charges applicable to parking on the highway or to suspend the use of parking spaces on the highway. Rounding has been applied on all hourly rates. Charges depend on the time purchased plus any surcharges; further information can be found on our P4P provider platforms.

1. Residents permits –

Charges applicable to residents in respect of vehicles left in parking places where the adjacent sign includes the words “Resident permit holders” and “Permit holders” together with a permit identification code beginning “CA” followed by an alphabetic character or characters.

Basic charges applying to conventionally powered vehicles:

The air quality surcharge applies to petrol vehicles that do not meet the Euro 6 standard (first registered prior to September 2015) and diesel vehicles that are not Euro 6d and Euro 6d-TEMP compliant (first registered prior to September 2019).

For vehicles first registered on or before 01 March 2001, we are reliant on engine size, where vehicles with an engine size of 0-1299cc are charged at the 121-150g/km rate, 1300-1849cc are charged at the 151-185g/km rate, 1850-2449 are charged at the 186-225g/km and 2450 and over are charged at the over 225g/km rate.

An Air Quality surcharge is also made for each vehicle registered to the permit which is payable again on renewal of the permit or if a car is substituted for another car.

Other charges applicable to residents permits:

These charges are only applicable to current permit holders until September 30, 2024. Residents may register up to three vehicles to each permit. A charge is payable in respect of the second and third vehicles at the time of registration and on renewal of the permit.

The basic charge is determined according to the tariff which is applicable to the vehicle with the highest rated emissions or engine size whether or not any other vehicle registered to the permit is electrically powered. The air quality surcharge applies to petrol vehicles that do not meet the Euro 6 standard (first registered prior to September 2015) and diesel vehicles that are not Euro 6d and Euro 6d-TEMP compliant (first registered prior to September 2019).

An Air Quality surcharge is also made for each vehicle registered to the permit which is payable again on renewal of the permit or if a car is substituted for another car.

8. Parking suspensions

The charge to suspend the use of a parking space comprises an administration fee plus a charge based on the number of parking space(s) and duration of time over which the parking space(s) will be suspended. A "parking space" is considered to be 5 metres. A charge for skip licenses will be added if this is the purpose of the request. A short notice fee applies in certain circumstances.
